BE IT KNOWN, that on the 31<sup>st</sup> day of August, 2001.

BEFORE ME, the undersigned, a Notary Public, duly commissioned and qualified in and for Lafayette Parish, Louisiana, and in the presence of the undersigned witnesses;

**PERSONALLY CAME AND APPEARED:**

SUE BELL (Social Security Number: 225-76-7932), a single woman, a resident of and domiciled in Lafayette Parish, Louisiana, whose current mailing address is 101 Chateau Place, Lafayette, Louisiana 70503;

(hereinafter referred to as "Bell"); and,

SUE BELL HOLDINGS, L.L.C. (Federal Tax Identification Number: 72-1511571), a Louisiana Limited Liability Company, with its principal place of business, registered office and domicile in Lafayette Parish, Louisiana, whose current mailing address is 101 Chateau Place, Lafayette, Louisiana 70503, represented herein by its General Manager, Sue Bell as per Managers Certificate attached hereto and made part hereof;

(hereinafter referred to as "The Company");

who declared that they did, and do by these presence, make an exchange of property on the express terms and conditions hereinafter set forth, as follows, to-wit:

In consideration of the transfer to Bell as set forth below, Bell does hereby grant, bargain, assign, set over, transfer and deliver with all legal warranties and with full substitution and subrogation in and to all the rights and actions of warranty which Bell may have against all preceding owners and vendors, unto The Company the following described property:

- A) All of the Trust's rights, titles and interest, including all mineral rights of every kind, character and nature, including but not limited to servitudes, royalties and leases, and also, including current production, together with all water wells and water rights in and to the following described property:

~~The central 48 acres of that 103.50 acres, more or less, situated in the eastern portion of the Northeast quarter of Section 19, Township 11 South, Range 2 East, Vermilion Parish, Louisiana, being bounded now or formerly as follows:~~

North by the remaining 27.25 acres of the 103.50 acres referred to above, owned by The Trust; South by the remaining 27.25 acres of the 103.50 acres referred to above, owned by The Trust; East by Verga Adams Mouton; and, West by The Trust.

**Less and Except:**

~~That certain parcel of land measuring 1 square acre, situated in Section 19, Township 11 South, Range 2 East, Vermilion Parish, Louisiana, including all buildings and improvements located thereon, the center of said 1 square acre parcel being located at the center of a larger 103.50 Acre tract owned by The Bell Family Trust by virtue of Entry Number: 9612305 of the records of Vermilion Parish, Louisiana, together with a 20 foot right-of-way for purposes of a driveway beginning at the front of the property described and extending to W.
